Program Description: Arkansas Career Pathways Initiative is designed to improve the earnings and post-secondary education attainments of Arkansas' low-income, Temporary Assistance for Needy Family (**TANF**) eligible parents and Temporary Employment Assistance (**TEA**) recipients. The initiative will help those adults attain the required skills need to earn a marketable educational credential for immediate entry into a high demand occupation and/or further advanced education. The initiative will emphasize such program components as job readiness education, basic skills, remediation, advanced skill training in high wage, high demand occupations and strong connections among two-year colleges, students and employers. In addition to helping move Arkansas Forward economically through education and training, the outcome of the initiative will be to assist Arkansas in meeting the goal of reducing the need for public assistance.

SAU Tech Career Pathways Mission: The goal of the Career Pathways Initiative at SAU Tech is to assist TANF-Eligible adults remove educational barriers leading to the obtaining of certificates and/or degrees necessary to secure high wage careers by providing financial services including the purchase of books and supplies, tutoring, networking, childcare, tuition and transportation assistance.

STUDENT ELIGIBILITY

In order for a student to meet eligibility guidelines, he or she must be:

- An Arkansas resident
- ➤ A parent or legal adult care giver of a child or children under the age of 21
- Receiving SNAP, Medicaid, AR Kids, be a current or former TEA recipient OR earn an annual income at or below 250% of the federal poverty level

To determine eligibility, an applicant must provide the following documentation:

- A current Arkansas issued ID or driver's license
- Birth Certificate(s) for child(ren)
- Social Security cards for applicant and child(ren)
- Copy of your most recent FEDERAL tax return with applicant's signature (1040 forms)

ENROLLMENT/INTAKE PROCESS

A potential student may apply for Career Pathways by stopping by the office located in Administration room 240 at SAU Tech **OR** by logging on to **arpathways.com** and complete the pre-apply tab. Completion of the pre-apply tab does not make you an active participant of Career Pathways.

Any student deemed eligible for Career Pathways Initiative services will receive an acceptance letter detailing what services the student/participant is eligible to receive. If an applicant is not eligible for services, the applicant will receive a letter explaining why they are not eligible for services.

General Education General Education-English General Education-History General Education-Math Students enrolling in courses at SAU Tech and requesting assistance from Career Pathways must complete an SAU Tech Admissions packet with the Admissions Office (870-574-4558) and the Free Application for Federal Student Aid (FAFSA). These applications are separate from the Career Pathways Application packet.

FINANCIAL ASSISTANCE

- **Assistance from Career Pathways IS NOT an entitlement**
- ** Financial awards are at the discretion of the program director and the Arkansas Career Pathways state office**
- **Awards/Services are based on available funding**
- **CPI program eligibility DOES NOT guarantee a student will receive Assistance**

TUITION

To be eligible for transportation assistance, program eligibility determination must be completed. For students to eligible for tuition assistance, students must exhaust all other sources of funding (PELL, Arkansas Rehab, Scholarships, WIOA). Student loans are not considered in the exhaustion policy. Students who receive funding for other sources but still have a balance remaining, may be eligible for assistance with the remaining balance. ALL eligibility documents must be received before tuition assistance will be provided. If CPI pays for courses and the student withdraws or fails for not attending, that student may not be eligible for tuition assistance the following semester. Tuition assistance is limited to 4 semesters. Additional semesters may be awarded at the discretion of the director.

TRANSPORTATION

To be eligible for transportation assistance, program eligibility determination must be completed. Basic transportation is available for travel to and from required class and CPI activities. Basic transportation is capped at **\$200.00 monthly**. Additional travel assistance is available for those traveling to clinical sites. Clinical transportation is capped at **\$300.00 monthly**. Miles driven will be determined using Map Quest from student's physical address to campus and back for basic and from student's physical address to the clinical rotation site and back for clinicals. To receive transportation assistance, a student must be:

• Be enrolled in the current semester

- Submit a current attendance form signed by the instructor or designated department staff with no more than 3 absences for the current monitoring period
- Submit attendance forms on time and pick up stipends in a timely manner

CHILDCARE

To be eligible for transportation assistance, program eligibility determination must be completed. Student must meet with CPI director **BEFORE** enrolling a child at a center if CPI is to help cover costs. Student must also:

- Choose a state licensed/certified facility
- Establish a contract with CPI and childcare facility
- Submit an attendance form for the month that payment is to be assisted
- Understand that monthly payment is based on available funding and the entire monthly bill may not by covered.
- Ensure that children are picked up from the facility on time. Any late fees charged will be the responsibility of the parent.

EDUCATION PAYS

Education Pays (Ed Pays) is an incentive assistance program developed to encourage CPI students/participants to maintain satisfactory progress while working toward attaining a credential. To qualify, a student/participant must meet certain income guidelines. Not every student/participant who qualifies for CPI will qualify for Ed Pays. Because Ed Pays is an incentive program, FUNDING IS NOT GUARANTEED every school year.

COURSE RELATED SUPPLIES

A course related supply is material required for a student to successfully complete a program of study. CPI does students with the purchase of required textbooks, uniforms, clinical supplies, lab kits and other supplies. In order to receive this assistance, student/participant must meet with CPI staff **BEFORE** payment is due.
