



## Concurrent Enrollment Registration Checklist

- ☐ **1. Online Admission Application** *(New students only \* students who have never taken a concurrent course through SAU Tech)*
  - Complete the online application for admission at [www.sautech.edu](http://www.sautech.edu).
  - **MUST** be completed before any paperwork will be processed.
  
- ☐ **2. Registration**
  - Registration/Consent Form — must be completed with ALL required signatures, course codes and section numbers. Registration/Consent forms must be turned in **every** semester. Forms without all required information **will not** be accepted or processed.
  - Registration/Consent Form must be turned in by the registration deadline. Forms submitted after the deadline **will not** be accepted or processed. See your high school counselor for registration deadline.
  - Test scores must be submitted along with the registration/consent form. Registrations without test scores **will not** be accepted or processed.
  - Students not meeting all course requirements will not be registered for class.
  
- ☐ **3. Payment**
  - Pay all tuition and fees not covered by your school district by the payment deadline. See your high school counselor for the payment deadline.
  - You may pay in person at the Business Office or over the phone with a credit or debit card.
  - Payment is required each semester.

- I understand I must complete an online application for admission, [www.sautech.edu](http://www.sautech.edu), by the date established by SAU Tech. If I do not, I may not be eligible to participate.
- I understand I must submit my complete concurrent registration form and meet concurrent course requirements by the date established by SAU Tech. If I do not, I may not be eligible to participate.
- I understand I must comply with SAU Tech's Code of Conduct or I may be dismissed from the program permanently. Students who do not comply with their high school's code of conduct may also be dismissed from the program permanently. Dismissal from the program may result in a failing grade.
- I understand, by choosing to enroll in concurrent courses, I will earn college credits that will become part of my permanent academic record.
- I understand concurrent high schools students are not eligible to enroll in developmental courses in reading, mathematics and English.
- I understand that I must complete the concurrent enrollment orientation before beginning my concurrent course.
- I understand the GPA I earn in my college courses may impact my high school GPA, and may also impact my future college admission and federal aid.
- I understand enrolling in college courses will incur tuition and fees.
- I understand I am responsible for any course related expenses or fines I incur that are not paid by my school district or SAU Tech.
- I understand for courses taken directly on the university campus, I will be responsible for paying full tuition if my school district does not pay all or part of tuition.
- I understand for courses taken at the high school, I will be responsible for paying half-tuition if my school district does not pay all or part of tuition.
- I understand for courses taken online, I will be responsible for paying half-tuition and fees if my school district does not pay all or part of tuition.
- In compliance with the **Family Educational Rights and Privacy Act (FERPA) of 1974**, the student gives permission to SAU Tech to report absences, disciplinary issues, and the release of grades, transcripts, in progress grade, class schedules, and billing information, as available, to the High School/School District noted below for any courses enrolled under the Rocket High Program.
